### Notice of Public Hearing

The Board of County Commissioners (the "County Commission") of Knox County, Tennessee (the "County") will hold a public hearing on Wednesday, January 22, 2025 at 4:00 p.m., local time, in the Small Assembly Room of the City County Building, at 400 Main Street in Knoxville, Tennessee, regarding the establishment of the 2814 Tipton Station Road Residential Infrastructure Development District (the "District") as a residential infrastructure development district pursuant to the terms of Tennessee Code Annotated Sections 7-84-701 *et seq.* (the "Act"). The proposed District is located on undeveloped property located at 2814 Tipton Station Road in Knox County, Tennessee.

The establishment of the District has been requested by a petition filed pursuant to the Act by D.R. Horton, Inc., the developer of the District, and each of the owners of the property located therein. If approved by County Commission, a special assessment would be levied against all parcels of property within the District to help defray a portion of the infrastructure costs required to develop the District.

All persons whose property may be affected thereby may appear at the public hearing in person, by attorney, or by petition and protest against the creation of the District.
